Brief Profile of Mr. Chandresh Haridas Ruparel (DIN: 01669081) is as follows:

Mr. Chandresh Ruparel has worked as a director and senior advisor with Rothschild & Co. India Pvt. Ltd. for 22 years (May 2003 to June 2025). Prior to which he led the India business for the firm.

Mr. Ruparel's role involved having detailed interaction with owners and senior management in helping assess their business, debating and rationalizing potential fund raising / inorganic initiatives and guidance in achieving a desired corporate finance outcome for stakeholders. Given his long-standing experience, he also helped leverage his connections and standing within the Advisory ecosystem in formulating strategic / tactical / negotiation advice to clients.
